The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

Name

The name of the corporation is Sign King of Sarasota, Inc.

ARTICLE II

Nature of Business

The general nature of the business to be transacted by the corporation is to carry on and conduct the business of general sign manufacturing, painting, installation, repair and maintenance of all types of signs; to buy and sell and otherwise deal in signs and the materials necessary for the making of signs; and the making, performing and discharging of contracts therefore or relating thereto as contractor or subcontractor.

To operate, manage and engage in any business not prohibited by Florida law and to do any and all things authorized to be performed by corporations under the corporation law of the State of Florida.

ARTICLE III

Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is Five Thousand (5,000) shares of common stock at the par value of One Dollar (\$1.00) per share.

ARTICLE IV

Initial Capital

The amount of capital with which this corporation will begin business is Five Hundred Dollars (\$500.00).

ARTICLE V

Term of Existence

This corporation is to exist perpetually.


ARTICLE XI


