The undersigned, for the purpose of forming a for-profit corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

**ARTICLE I.
NAME**

The name of this corporation shall be **DR. MATTIE R. SHANNON GLOBAL INSTITUTE FOR EARLY CHILDHOOD EDUCATION AND DEVELOPMENT, INC.** (hereinafter called the "Corporation.")

**ARTICLE II.
PRINCIPAL OFFICE AND MAILING ADDRESS**

**ARTICLE III.
PURPOSE**


