ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF ASSET, FLORIDA
FACTORWORKS, INC.

FACTORWORKS, INC., a Florida corporation (the "Corporation") whose Articles of Incorporation were originally filed with the Florida Department of State on November 18, 2010 (Florida Division of Corporations Document Number P10000094743), hereby certifies as follows:

1. The Articles of Incorporation of the Corporation are hereby amended by deleting the present form of Article I in its entirety and by substituting, in lieu thereof, the following:

"ARTICLE I

CORPORATE NAME AND PRINCIPAL OFFICE

The name of this corporation is SILVERTON OF TAMPA, INC. (the "Corporation") and its principal office and mailing address is 7257 NW 4th Boulevard, Suite #271, Gainesville, Florida 32607.

2. The foregoing amendment shall become effective as of the close of business on the date these Articles of Amendment are approved by the Florida Department of State and all filing fees then due have been paid, all in accordance with the corporation laws of the State of Florida.

3. The amendment recited in Section 1 was adopted by the incorporator of the Corporation without shareholder action. Shareholder action was not required as set forth in Fla. Stat. §607.1005 as the Corporation had yet to issue any shares of its capital stock.
