The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

**ARTICLE I**

The name of the corporation is: SUBWAY NORTH, INC.

The maximum number of shares of stock of the corporation shall have authority to issue is as follows:

- (a) 1,000 shares of voting common stock, having a par value of \$1.00 per share, and

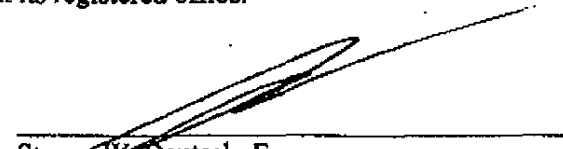
