ARTICLES OF INCORPORATION

OF

YELLOW BRICK ROAD OF CENTRAL FLORIDA, INC.

ARTICLE I - NAME

The name of the corporation is Yellow Brick Road of Central Florida, Inc., at 6281 Whispering Lane, Titusville, FL 32780 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 500 shares of One Dollar (\$1.00) par value common stock, which shall be designated "Common Shares".
