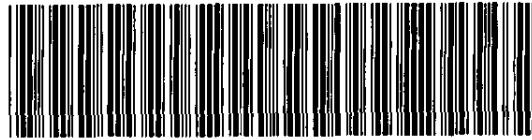

THE NAME OF THIS CORPORATION IS:

ARTICLE II – DURATION

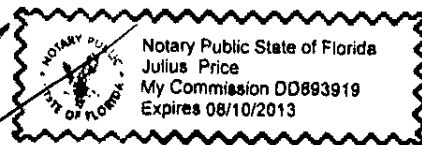
