ARTICLES OF INCORPORATION  
OF  
HR HOMES, INC.SECRETARY OF STATE  
TALLAHASSEE, FLORIDA

The undersigned, acting as incorporator of HR Homes, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is HR Homes, Inc.

ARTICLE II. ADDRESS

The address of the corporation is 1413 Tech Blvd., #112, Tampa, Florida 33619.

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence upon filing these articles of incorporation.

ARTICLE IV. PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$.01 per share.


ARTICLE IX. BYLAWS
