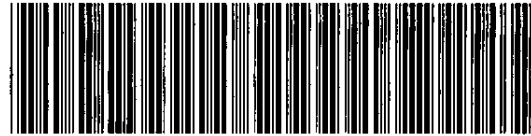

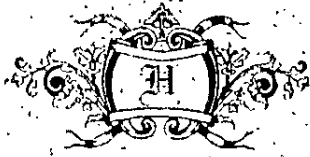

M. B. Hughes & Associates Inc. The undersigned for the purpose of performing a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

Article 1-

The name of this corporation is M.B. Hughes & Associates, Inc.

Article II-

Duration- The duration of this corporation is perpetual.

Article III

Registered Office Address and Registered Agent

The office is located at 8225 103rd Street, Jacksonville, FL. 32210. The name of the initial registered agent is M.B. Hughes at 8225 103rd Street, Jacksonville, FL 32210

Article IV-Purpose

- The general purpose for which this corporation is organized are the following:
 - a. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way; and
