

ARTICLES OF INCORPORATION

ARTICLE I

The name of this corporation is: **Murphy Anesthesia, P.A.**

ARTICLE II

The effective date of this corporation shall be January 1, 2011. The term of existence of the corporation is perpetual.

ARTICLE III

This corporation is organized for the following purposes:

A. To engage in anesthesia services as a professional corporation and to carry on services incident thereto. The practice of anesthesia services is the sole and exclusive professional service to be rendered by this corporation.

B. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.

C. The professional services of this corporation shall be carried out only through officers, employees, and agents, each of whom is duly authorized by law in the State of Florida.

D. Any and all other lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00

par value common stock.

ARTICLE V - PRE EMPTIVE RIGHTS

Each shareholder upon the sale for cash of any new stock of this corporation of the same kind, class or series of that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price of which it is offered to others.

ARTICLE VI - INITIAL REGISTERED

OFFICE AND AGENT


ARTICLE IX - BYLAWS




