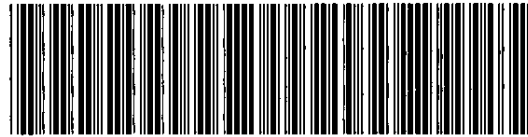




## ARTICLE XI - AMENDMENT
