ARTICLE I

The name of this corporation shall be <u>Safe Health Group</u>, <u>Inc</u>. its principal place of business shall be at 6190 SW 96 Avenue, Miami, FL 33173 the right to change and move said principal place of business and establish such other offices and place of business within or without the State of Florida, as the Board of Directors may from time to time deem proper.


