ARTICLES OF INCORPORATION OF ANTHONY J. DIGIORE, P.A.

The undersigned, acting as Incorporator of a Florida professional service corporation (the "Corporation") under the Professional Service Corporation Act, Chapter 621 of the Florida Statutes, and other laws of the State of Florida, hereby causes to be delivered the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME AND ADDRESS

The name of the Corporation is Anthony J. DiGiore, P.A., and the street address of the initial principal office of the Corporation is 1451 Ocean Drive, Suite 205, Miami Beach, Florida 33139, and the mailing address of the Corporation is 1451 Ocean Drive, Suite 205, Miami Beach, Florida 33139.
