

## ARTICLES OF INCORPORATION OF

#### **RPC PARTNERS, INC.**

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

#### ARTICLE !

#### Name

The name of the corporation is RPC Partners, Inc..

#### **ARTICLE II**

#### **Principal Office**

The principal office and mailing address of the corporation shall be 4448 Worth Dr. W., Jacksonville, Florida 32207.

#### **ARTICLE III**

#### Duration

This corporation shall exist perpetually.
