**ARTICLE 1
NAME**

The name of the corporation is The Doherty Group, Inc. (the "Corporation").

**ARTICLE 2
PRINCIPAL OFFICE**

The street address of the initial principal office of the Corporation is 7 Pearl Court, Allendale, New Jersey 07401.

**ARTICLE 3
AUTHORIZED SHARES**

The Corporation shall have authority, to be exercised by the Board of Directors, to issue no more than two thousand five hundred (2,500) shares of capital stock. These shares shall be one class, without par value, and shall be designated as "Common Stock." The holders of Common Stock shall have unlimited voting rights and shall be entitled to receive the net assets of the Corporation upon dissolution.
