The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the Laws of the State of Florida.

ARTICLE I

Name

The name of the corporation is: UNIVERSITY SERVICES UTE, CORP.

ARTICLE II

Principal Office and Mailing Address

Nature of Business
