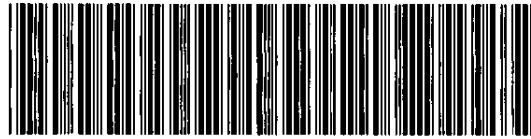


**CUMULATIVE VOTING:**
