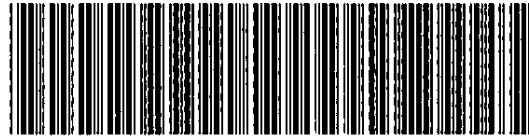

ARTICLE ONE

The name of this corporation is Lucky Tax Service, Inc. and the mailing address of the corporation shall be 2358 Harvard Avenue, Fort Myers, Florida 33907.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed with the Secretary of State.

ARTICLE THREE

The duration of the corporation is perpetual.

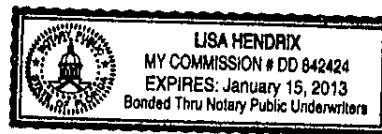
