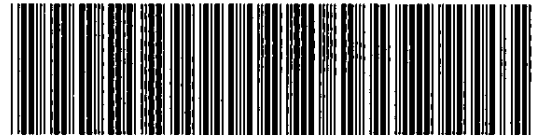



ARTICLE ONE

The name of the corporation is **SUNCOASTAL GROUPS, INC.**


ARTICLE EIGHT


