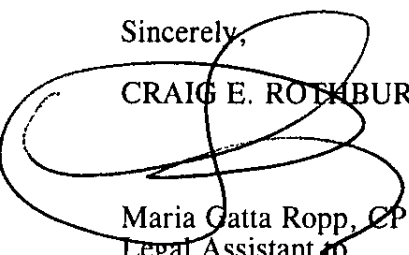

**I.**

The Name of the corporation shall be:
