ARTICLES OF INCORPORATION
OF

Pursuant to Chapter 607 of the Florida Statute (the "Florida Business Corporation Act"), the undersigned, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME AND PRINCIPAL OFFICE

The name of the corporation shall be WASABI PALM HARBOR, INC. (hereinafter the "Corporation"), and the principal office shall be at 36221 East Lake Road, Palm Harbor, FL 34684.
