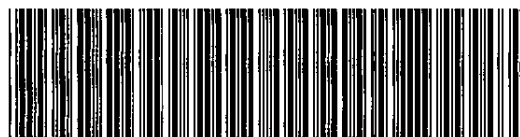

The undersigned, **Charles R. Pennington**, acting as Incorporator and as one of the initial Directors of a Corporation to be formed under the Florida Business Corporation Act, Chapter 607, Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

Effective Date *Jan. 01, 2011*

DURATION AND COMMENCEMENT OF EXISTENCE

The duration of this Corporation is perpetual. The time of commencement of its existence is immediately upon filing.

ARTICLE III
