**ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION  
OF

Pursuant to the provisions of Section 607.1006, F.S., SMS MANAGEMENT COMPANY, INC., hereby adopts the following amendments to its Articles of Incorporation.

1. Name of Corporation: SMS MANAGEMENT COMPANY, INC.
