ARTICLES OF INCORPORATION

OF

DEREK HINDLE, INC.

ARTICLE I - NAME

The name of the corporation is Derek Hindle, Inc., at 1871 Cogan Drive, Palm Bay, FL 32909 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
