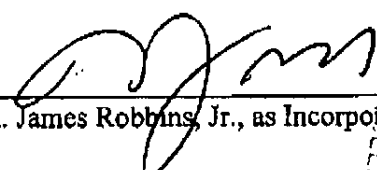
ARTICLE NINE – AMENDMENT

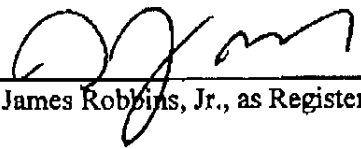
ARTICLE TEN – BYLAWS
