NAME

The name of this corporation is Kore Properties II, Inc.



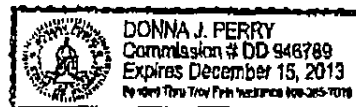
