The undersigned subscribers to these Articles of Incorporation, being natural person competent to contract, hereby form a corporation under and pursuant to the laws of the State of Florida providing for the formation, liability, rights, privileges and immunities of corporation for profit, and for that purpose, hereby certify, declare and set forth as follows, to wit:

ARTICLE I

NAME OF THE CORPORATION

The name of the corporation shall be: AMSON LAWN SERVICE, INC.

ARTICLE II

PRINCIPLE OFFICE

The principal street and mailing address is 508 NW 8TH Street. Boynton Beach, Florida 33426.

ARTICLE III

GENERAL NATURE OF BUSINESS

The corporation may engage in helping the community with their lawn care service by helping them with tree and bush trimming; tree planting and removal; wood fence installation and sprinkler repair.

ARTICLE IV

DURATION

This corporation shall exist perpetually unless sooner dissolved according to the law of the United States of America.

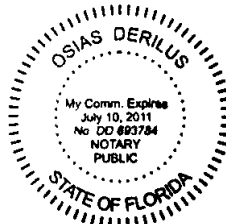
