ARTICLE I
NAME and PRINCIPAL PLACE OF BUSINESS

EFFECTIVE DATE 12-20-10

The name of this corporation is Bailey's Superior Flooring, Inc., and its principal place of business is 4817 Wingate Road, Myakka City, Florida, 34251.

ARTICLE II
DURATION

This corporation shall come into existence upon the execution of these Articles and shall exist perpetually.

ARTICLE III
PURPOSE

This corporation is organized for the purpose of any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV
POWERS

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.

The power to adopt, alter, amend or repeal by-laws shall be vested in the shareholders.


ARTICLE XI

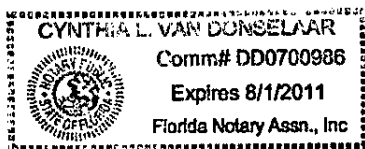


