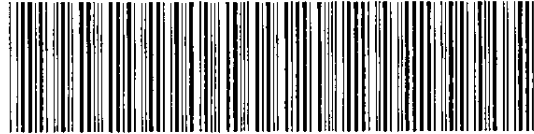

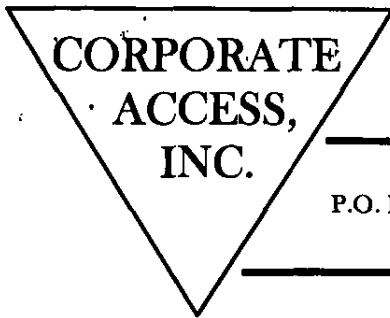

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of the corporation is D & R EXPORTS, INC.

**ARTICLE II - PRINCIPAL OFFICE**

The street address of the principal place of business of this corporation is 5754 SR 542 West, Suite #5, Winter Haven, Florida 33880 and mailing address of this corporation shall be 5754 SR 542 West, Suite #5, Winter Haven, Florida 33880.

**ARTICLE III - PURPOSE**

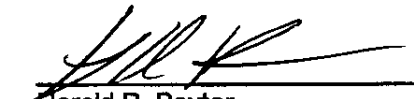
