**ARTICLES OF INCORPORATION

The undersigned natural person, competent and licensed to practice podiatry in the State of Florida, acting hereby as Incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Section 607, Florida Business Corporation Act, and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

**I.**

**Name of Corporation, Principal Office and Mailing Address**

The name of this Corporation shall be NEIL KRAVITZ, D.P.M., P.A. The principal office of this Corporation shall be 1860 N. Pine Island Rd, Suite 106, Plantation, Florida, 33322.

**Purposes**

The general nature and purposes of business to be transacted, promoted and carried on by the Corporation are as follows:

#### **Capital Stock**

a. The maximum number of shares of stock that the Corporation is to have outstanding at any time shall be 1,000 shares of common stock at \$ .001 per share par value.

### **Board of Directors**

### **Severance and Termination of Employment**

If any officer, director, stockholder, agent or employee of this Corporation becomes legally disqualified to render the professional services for which the Corporation is organized, or accepts employment that places restrictions and limitations on his continued rendering of such professional services, he shall forthwith sever all employment with the Corporation and shall not thereafter share, directly or indirectly, in any earnings or profits realized by the Corporation on account of professional services. The Corporation shall forthwith, upon such disqualification of shareholder purchase such shareholder's shares and pay shareholder all amounts owing and lawfully due to shareholder by the Corporation, except that such shares shall not be entitled to dividends.

## **X.**

### **Informal Director Action**

If all of the Directors severally or collectively consent in writing to any action taken or to be taken by the Corporation, and the writings evidencing their consent are filed with the Secretary of the Corporation, the action shall be as valid as though it had been authorized at a meeting of the Board of Directors.

**Indemnification**


The Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

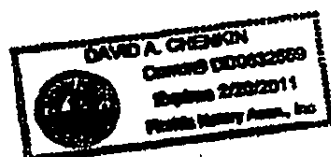


