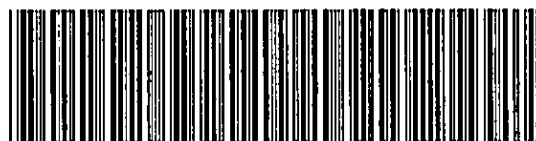




**ARTICLES OF AMENDMENT to
