

ARTICLES OF INCORPORATION SECRETARY OF STATE

ARTICLE I. NAME

The name of this corporation is TWO BROTHERS MOWING, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE






