## ARTICLES OF INCORPORATION

THE UNDERSIGNED, desiring to incorporate a corporation under the provisions of the Florida Corporation Act does hereby certify:

1. The name of the corporation is STRATTON & ROMAN, P.A.
2. The term for which the corporation is to exist is perpetual.
3. The general nature of the business to be transferred by the corporation shall be to engage in the general practice of law; and the corporation shall further have the power to engage in and to do any lawful act permitted under the laws of the United States of America and of the state of Florida, as limited by the provisions of the Professional Service Corporation Act.
4. The aggregate number of shares of capital stock which the corporation shall have the authority to issue is five hundred (500) shares of common stock having a par value of one dollar (\$1.00) each.
5. The initial principal offices of the corporation shall be located at 407 Lincoln Road, Suite 2A, Miami Beach, Florida, 33139.
6. The initial Board of Directors shall comprised of two (2) members. The number of Directors may be either increased or diminished from time to time by the Bylaws but shall never be less than one (1).


