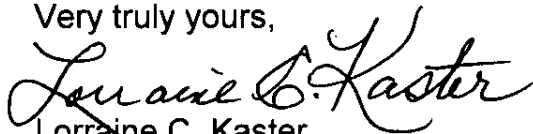

ARTICLE I - Name

EFFECTIVE DATE 1-3-11

The name of the corporation shall be: **GOLDEN COMB HAIR STYLING, INC.**

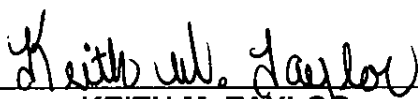
