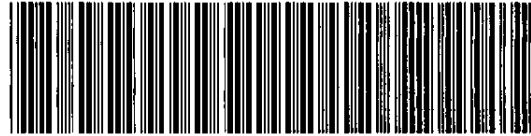

In compliance with the requirements of Chapter 607, F.S., and for the purposes of forming a for-profit business corporation in Florida, the undersigned desire to form a corporation according to the following Articles of Incorporation.

1. **Corporate Name**

The name of the corporation is Moss Cleaning Service Corporation (the "Corporation").

2. **Purpose**

The corporation is formed to provide Residential and Commercial Maintenance and cleaning services, and for the purpose of engaging in any lawful business.

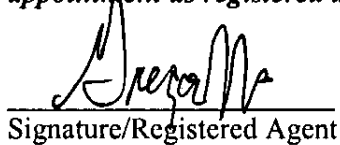
3. **Duration**

The initial Bylaws of the Corporation shall be adopted by the Board of Directors. The Bylaws may be amended from time to time in the manner provided for therein.

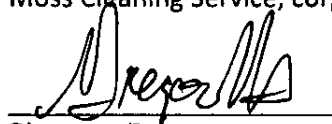
10. **Indemnities**
