Pursuant to the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, the undersigned incorporator of **Wilson Executive Search, Inc.**, a Florida corporation (the "Corporation"), hereby adopts the following Articles of Incorporation for the Corporation:

ARTICLE I
NAME AND ADDRESS

The name of this Corporation is **Wilson Executive Search, Inc.** The street and mailing address of the Corporation is 2509 A Bay Boulevard, Indian Rocks Beach, FL 33785.

ARTICLE II
BUSINESS AND ACTIVITIES

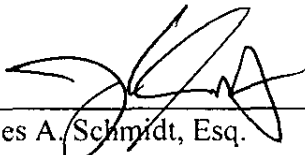
ARTICLE VII
