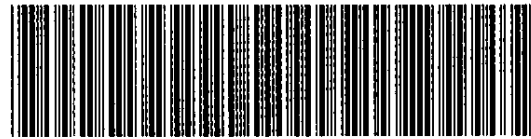



Section 1.1: The name of the corporation shall be known as Agape Better Homes Inc., as incorporated under the laws of the State of Florida


