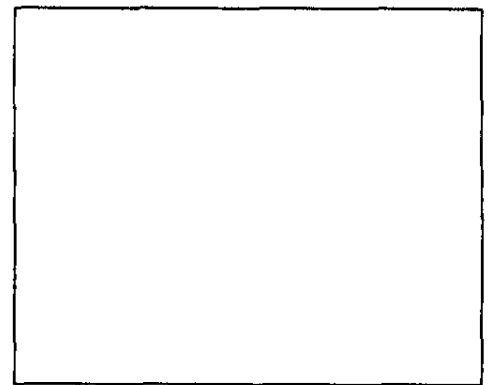

AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
SAM'S GROUP OF COMPANIES, INC.

The undersigned does hereby execute, acknowledge and file the following Amendment to the Articles of Incorporation of SAM'S GROUP OF COMPANIES, INC.

1. The name of the Corporation is currently SAM'S GROUP OF COMPANIES, INC.
2. The date of the filing of the Articles of Incorporation was January 18, 2011 and assigned Document No. P11000005809.
3. The Articles of Incorporation are amended as follows:
 - a. By deleting all of Article IV of the Articles of Incorporation, and by substituting in lieu thereof, all of the following:

"ARTICLE IV

The maximum number of shares of stock of this corporation that may be issued is 1,100, consisting of 100 voting common shares having a par value of \$1.00 per share and 1,000 non-voting common shares without par value. Each class of shares shall be identical in all respects, except that the non-voting shares shall carry no right to vote for the election of directors of the corporation, and no right to vote on any matter presented to the shareholders for their vote or approval except only as the laws of this state require that voting rights be granted to such non-voting shares."

- b. In all other respects, the Articles of Incorporation shall remain unchanged.
4. This Amendment was adopted by a written statement signed by the sole shareholder and director of SAM'S GROUP OF COMPANIES, INC. on the 1st day of November, 2012, pursuant to Section 607.1003 of the Florida Statutes.


