ARTICLES OF INCORPORATION

OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is **KEVIN MACWILLIAM, P.A., ATTORNEY AT LAW** herein after referred to as the "corporation."

ARTICLE II


