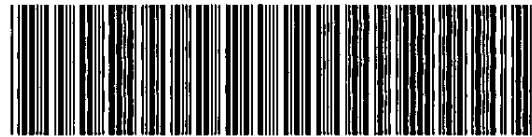

ARTICLE I. NAME

The name of this corporation is GLOBAL PROJECTS 321, INC.
