#### ARTICLES OF INCORPORATION

OF

#### HANANIA AUTOMOTIVE CORP. SIX, A FLORIDA CORPORATION

Pursuant to the provisions of Chapter 607, Florida Statutes, as amended, the following are hereby adopted and filed as the Articles of Incorporation of this Florida corporation for profit:

#### ARTICLE I - NAME

The name of this Corporation shall be: Hanania Automotive Corp. Six

#### ARTICLE II - INITIAL PRINCIPAL OFFICE

The shares of stock may be issued for such consideration as determined from time to time by the Board of Directors. Said consideration is to be paid in cash or other property, tangible or intangible, or in labor or services actually performed for the Corporation.

#### ARTICLE VI - INITIAL REGISTERED AGENT AND OFFICE
