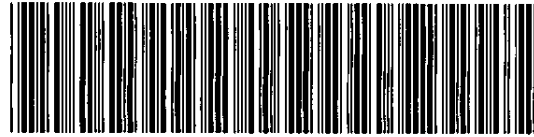

ARTICLE I – Name of Corporation

The name of this professional service corporation is Thomas J. Morton, P.A.

ARTICLE II – Initial Principal Place of Business

The initial principal office of this professional service corporation is 1117 Waverly Road, Tallahassee, Florida 32312.
