



ARTICLES OF INCORPORATION OF SCENIC MIAMI-DADE COUNTY, INC.

The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I: NAME OF CORPORATION

The name of the Corporation is Scenic Miami-Dade County, Inc.

ARTICLE II: ADDRESS

The principal street address and mailing address of the Corporation is 19 W. Flagler Street, Suite 607, Miami, Florida 33130-4408.

ARTICLE III: CAPITAL STOCK

The maximum number shares of capital stock that the Corporation is authorized to issue and have outstanding at any time is Five Thousand (5,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

ARTICLE IV: INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The initial street address of the registered office of this Corporation in the State of Florida shall be 19 W. Flagler Street, Suite 607, Miami, Florida 33130-4408. The Board of Directors may from time to time move the registered office to any other address in Florida. The initial name of the registered agent of this Corporation at that address is William S. Pollak. The Board of Directors may from time to time designate a new registered agent.

ARTICLE V: INCORPORATOR

ARTICLE VI: INITIAL BOARD OF DIRECTORS

- A. The initial number of directors for this Corporation shall be three (3).
- B. The number of directors may be increased or decreased from time to time in accordance with the Bylaws of this Corporation, but shall never be less than one (1).

The purposes for which the Corporation is organized are as follows:

- b. To promote education of the public about the economic, social, and cultural benefits of protecting and enhancing scenic resources and community appearance.
 - c. To coordinate efforts to preserve and enhance visual resources.
- d. To provide information to appearance commissions, garden clubs, historic preservation groups, environmental organizations, civic groups, government agencies, and other individuals and organizations interested in preserving and enhancing visual resources.
- e. To research, study, and analyze federal, state, and local policies affecting Miami-Dade County's visual appearance.
- f. To encourage and foster any other such activity that has the purpose of promoting appreciation and preservation of scenic resources within Miami-Dade County.
- g. To do anything, perform any act, and exercise any right or any power now or hereafter conferred by the laws of the State of Florida upon a corporation organized under Chapter 607 of the Florida Statutes and the laws of the State of Florida, and in general to carry on any of the activities herein set forth to the same extent and as fully as a natural person might or could do.

ARTICLE VIII: INDEMNIFICATION

This Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE IX: DATE OF EXISTENCE

This Corporation shall exist perpetually, commencing on the date of filing these Articles of Incorporation with the Secretary of State.
