ARTICLES OF INCORPORATION

OF

MARTIN G. MONDRY, M.D., P.A.

ARTICLE I

The name of this corporation is: Martin G. Mondry, M.

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III

This corporation is organized for the following purposes:
