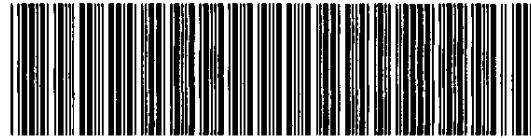

ARTICLES OF INCORPORATION

OF

MARTIN G. MONDRY, M.D., P.A.

ARTICLE I

The name of this corporation is: **Martin G. Mondry, M.D.**

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III

This corporation is organized for the following purposes:

A. To engage in medical and anesthesia services as a professional corporation and to carry on services incident thereto. The practice of medical and anesthesia services is the sole and exclusive professional service to be rendered by this corporation.

B. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.

C. The professional services of this corporation shall be carried out only through officers, employees, and agents, each of whom is duly authorized by law in the State of Florida.

D. Any and all other lawful business.


ARTICLE X - BYLAWS






