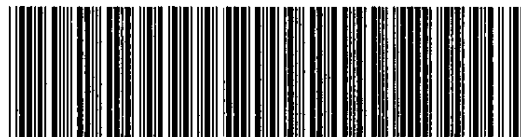

ARTICLES OF INCORPORATION

of

AVIMAN, INC.

Article I -- Name

The name of this corporation is AVIMAN, INC.

Article II -- Duration

This corporation shall exist for a perpetual period of time.

Article III -- Purpose

This corporation is organized for the purpose of any lawful business, including property management.

Article IV -- Capital Stock

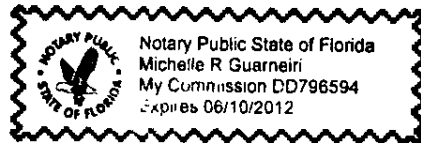

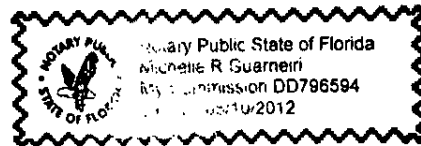


