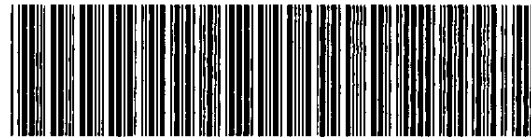

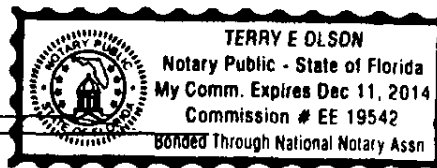
1. Introduction. Diane Ackerman, being duly sworn, deposes and says:


