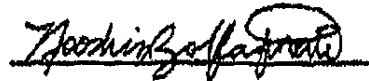

ARTICLE XI - AMENDMENT

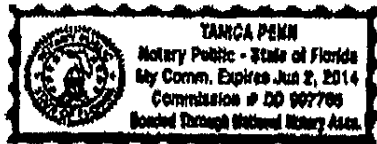
