The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I: NAME**

The name of the corporation shall be:

**ARTICLE II: NATURE OF BUSINESS**

This corporation is organized for the purpose of engaging in the business of interior trim services and transacting any or all other lawful business permitted under the laws of the State of Florida or any other state and of the United States.






