

ARTICLES OF INCORPORATION OF CYBER SHARK MEDIA, INC.



<u>ARTICLE I. NAME</u>

The name of this corporation shall be Cyber Shark Media, Inc.

ARTICLE II. PRINCIPAL OFFICE
