The undersigned person(s), being of legal age and sui juries, in the capacity Repa incorporator(s) of the following corporation under the Florida Business Corporation Act, hereby file these Articles of Incorporation of Protégé Signature Pools and Spas, Inc., a Florida For-Profit Corporation, pursuant to Section 607, Florida Statutes:
